

# SPDR<sup>®</sup> SSGA My2029 Corporate Bond ETF

## Key Features

- The SPDR<sup>®</sup> SSGA My2029 Corporate Bond ETF employs an actively managed target maturity strategy that provides exposure primarily to corporate bonds maturing in 2029 and is designed to distribute any remaining principal and liquidate on or about December 15, 2029.
- The fund seeks to maximize current income while seeking preservation of capital using a risk-aware, top-down approach combined with bottom-up security selection through rigorous fundamental research to construct a portfolio that seeks to overweight the most attractive sectors and issuers.
- The fund is one of the SPDR<sup>®</sup> SSGA MyIncome ETFs, a suite of target maturity funds allowing investors to efficiently build custom bond ladder portfolios to manage interest rate risks, cash flows, and liquidity needs.

## About This Benchmark

The ICE 2029 Maturity US Corporate Index tracks the performance of U.S. corporate bonds with maturities between January 1<sup>st</sup> and December 31<sup>st</sup>, 2029. The index constituents are market capitalization weighted, must have an investment grade rating, at least one day remaining term to final maturity, at least 18 months to final maturity at the time of issuance, and minimum amount outstanding of \$250 million.

#### Glossary

**NAV** The market value of a mutual fund's or ETFs total assets, minus liabilities, divided by the number of shares outstanding.

**Market Value** Determined by the midpoint between the bid/offer prices as of the closing time of the New York Stock Exchange (typically 4:00PM EST) on business days.

**Gross Expense Ratio** The fund's total annual operating expense ratio. It is gross of any fee waivers or expense reimbursements. It can be found in the fund's most recent prospectus.

**30 Day SEC Yield** (Also known as Standardized Yield) An annualized yield that is calculated by dividing the net investment income earned by the fund over the most recent 30-day period by the current maximum offering price.

**Average Maturity** The market value-weighted average maturity of the bonds and loans in a portfolio, where maturity is the length of time during which the investor will receive interest payments on the investment. When the bond reaches maturity the principal is repaid.

**Average Yield To Worst** The lowest potential yield that can be received on a bond without the issuer actually defaulting. The YTW is calculated by making worst-case scenario assumptions on the issue by calculating the return that would be received if the issuer uses provisions, including prepayments. When aggregating YTW for a portfolio level statistic, the weighted average

of the YTW and market value for each security is used.

**Average Coupon** The market value weighted average coupon of the bonds in a portfolio.

**Average Price** The weighted average of each asset's market price relative to its face value or par value.

**Option Adjusted Duration** Also known as effective duration which is a duration calculation that takes into account the effect of embedded options in bonds. An option-adjusted measure of a bond's (or portfolio's) sensitivity to changes in interest rates calculated as the average percentage change in a bond's value (price plus accrued interest) under shifts of the Treasury curve +/- 100 bps.

**Yield to Maturity** The market weighted average rate of return anticipated on the bonds held in a portfolio if they were to be held to their maturity date.
