SPDR MSCI Europe Climate Paris Aligned UCITS ETF

A. Resumé

SPDR MSCI Europe Climate Paris Aligned UCITS ETF ("fonden") er en indeksfond, der følger resultaterne af MSCI Europe Climate Paris Aligned Index. Indekset er udvalgt med henblik på at opnå de miljømæssige og sociale karakteristika, som fonden fremmer. De miljømæssige og sociale karakteristika, som fonden fremmer, er det indeks, som fonden har udpeget. Indekset sigter mod at vise resultaterne af en delmængde af aktier fra virksomheder inden for MSCI Europe Index ("moderindekset") med henblik på at reducere eksponeringen for overgangsrisici og fysiske klimarisici, samtidig med at man udnytter de muligheder, der opstår i forbindelse med overgangen til en økonomi med lavere kulstofemissioner, og samtidig med, at man søger at tilpasse fondens portefølje til Parisaftalen, der er vedtaget i henhold til kravene i FN rammekonvention om klimaændringer ("Parisaftalen").

Fonden fremmer miljømæssige eller sociale egenskaber men har ikke bæredygtig investering som sit mål.

De miljømæssige og sociale karakteristika, som fonden fremmer, er det indeks, som fonden har udpeget. Indekset sigter mod at vise resultaterne af en delmængde af aktier fra virksomheder inden for MSCI Europe Index ("moderindekset") med henblik på at reducere eksponeringen for overgangsrisici og fysiske klimarisici, samtidig med at man udnytter de muligheder, der opstår i forbindelse med overgangen til en økonomi med lavere kulstofemissioner, og samtidig med, at man søger at tilpasse fondens portefølje til Parisaftalen, der er vedtaget i henhold til kravene i FN rammekonvention om klimaændringer ("Parisaftalen"). Desuden udelukker indekset visse virksomheder på grund af deres deltagelse i følgende kontroversielle forretningsaktiviteter: kontroversielle våben, tobak, olie og gas samt udvinding af termisk kul og elproduktion, med yderligere oplysninger om, hvordan indeksudbyderen definerer, hvad der udgør "deltagelse", som beskrevet i indeksmetoden. Indekset udelukker selskaber, som indeksudbyderen har konstateret er involveret i kontroverser, der har en negativ ESG-påvirkning på deres aktiviteter og/eller produkter og tjenester baseret på en MSCI ESG-tvistscore ("MSCI ESG Controversy Score").

Investeringsforvalteren og/eller underinvesteringsforvalteren vil på vegne af fonden investere ved brug af replikationsstrategien som beskrevet yderligere i afsnittet "Investeringsmål og -politikker - Indeksopfølgende fonde" i prospektet, primært i indeksets værdipapirer, og til enhver tid i overensstemmelse med de investeringsbegrænsninger, der er anført i prospektet.

Investeringsforvalteren anvender en bindende ESG-metode, der sigter mod at opbygge en portefølje, hvor mindst 90 % af fondens aktiver er investeret i værdipapirer, som er i overensstemmelse med de miljømæssige og sociale karakteristika, som fonden fremmer. Den resterende del (<10 %) af porteføljen, som består af kontanter og kontantækvivalenter, der besiddes efter investeringsforvalterens skøn, vil ikke være i overensstemmelse med de miljømæssige og sociale

karakteristika, der fremmes. I det omfang fonden måtte anvende finansielle derivatinstrumenter, vil disse ikke blive anvendt til at opnå de miljømæssige eller sociale karakteristika, som fonden arbejder for. Fonden forpligter sig ikke til at foretage bæredygtige investeringer som defineret i SFDR eller taxonomiforordningen.

Den andel af fondens portefølje, der er investeret i værdipapirer, som indgår i indekset, vil udgøre en bæredygtighedsindikator, der anvendes til at måle opnåelsen af hver af de miljømæssige eller sociale karakteristika, som fonden fremmer.

Linket til den indeksmetode, som opfanger de miljømæssige eller sociale karakteristika, der fremmes af fonden, findes i det relevante tillæg og er medtaget nedenfor.

De datakilder, der anvendes til at opnå de relevante miljømæssige eller sociale karakteristika, er nærmere beskrevet i indeksmetoden.

Der er en risiko for, at indeksudbyderen kan lave fejl, f.eks. urigtig vurdering af screeningskriterierne som beskrevet i investeringspolitikken og/eller på urigtigt grundlag medtager/udelukker bestanddele af indekset i forbindelse med screeningen. ESG-data kan være baseret på visse antagelser, prognoser, fremskrivninger, synspunkter og udtalelser, som kan være baseret på aktuelle markedstendenser eller forventede fremtidige begivenheder. Da datamodeller, metoder og antagelser er under udvikling og innovative og på grund af den iboende usikkerhed ved forudsigelse af fremtidige begivenheder, kan det ikke garanteres, at ESG-data altid er præcise eller korrekte, eller at ESG-dataene vil opfylde målene eller kravene for en bestemt kunde eller investor. Desuden kan der være data, der ikke kan indhentes på grund af manglende adgang til datakilder.

SSGA fører tilsyn med eksterne leverandører, herunder indeksudbydere, i overensstemmelse med sit program for risikostyring af tredjepartsrisici. SSGA har regelmæssigt kontakt med indeksudbyderne i forbindelse med undersøgelser af serviceniveau og foretager også målrettede undersøgelser af indeksudbydernes procedurer, systemer og systemkontroller, data, kvalitetskontrol og it-sikkerhed.

SSGA's engagementspolitikker er ikke direkte integreret i fondens investeringsstrategi. SSGA's Asset Stewardship-program konsoliderer imidlertid alle afstemnings- og engagementaktiviteter på tværs af aktivklasser, uanset investeringsstrategi eller geografisk region, herunder for så vidt angår fonden.

Fonden har udvalgt indekset med henblik på at opnå de miljømæssige og sociale karakteristika, som fonden fremmer. Indekset opgøres halvårligt ved lukketid på den sidste bankdag i maj og november.

B. No sustainable investment objective

The Fund promotes environmental or social characteristics, but does not have as its objective a sustainable investment.



C. Environmental or social characteristics of the financial product

The environmental and/or social characteristics promoted by the Fund are those promoted by the MSCI Europe Climate Paris Aligned Index (the "Index") which the Fund tracks. The Index aims to reflect the performance of a sub-set of equity securities of companies within the MSCI Europe Index (the "Parent Index"), to reduce exposure to transition and physical climate risks while pursuing opportunities arising from the transition to a lower-carbon economy and seeks to align with the Paris Agreement adopted under the United Nations Framework Convention on Climate Change requirements (the "Paris Agreement").



D. Investment Strategy

The investment policy of the Fund is to track the performance of the Index (or any other index determined by the Directors from time to time to track substantially the same market as the Index) as closely as possible, while seeking to minimise as far as possible the tracking difference between the Fund's performance and that of the Index.

The Index aims to reflect the performance of a sub-set of equity securities of companies within the Parent Index which are selected and weighted in accordance with the Index methodology. The Index methodology aims to reduce exposure to transition and physical climate risks while pursuing opportunities arising from the transition to a lower-carbon economy and seeking to align the Fund's portfolio with the Paris Agreement adopted under the Paris Agreement. The Parent Index measures the performance of large and mid-capitalisation stocks across developed market countries in Europe. The Index aims to exceed the minimum standards for EU Paris-Aligned benchmarks set out in the Commission Delegated Regulation (EU) 2020/1818 for the methodology of benchmark indices that would be aligned with the objectives of the Paris Agreement. The Index excludes certain companies based on their involvement in the following controversial business activities: controversial weapons, tobacco, oil and gas, and thermal coal mining and power generation, with further detail on how the Index provider defines what constitutes "involvement" outlined in the Index methodology. The Index also excludes companies which are identified by the Index provider as being involved in controversies that have a negative ESG impact on their operations and/or products and services based on an MSCI ESG controversy score ("MSCI ESG Controversy Score").

The Investment Manager and/or Sub-Investment Manager, on behalf of the Fund, will invest using the replication strategy as further described in the "Investment Objectives and Policies – Index Tracking Funds" section of the Prospectus, primarily in the securities of the Index, at all times in accordance with the Investment Restrictions set forth in the Prospectus.

Companies deemed not in violation by the Index provider of the UNGC principles are considered to exhibit good governance. E. Proportion of investments

Environmental and social characteristics are promoted via the adoption of screens and best in class criteria within the Index .

At least 90% of the Fund's assets are invested in securities that are constituents of the Index and aligned with environmental and / or social characteristics, while the Index provider applies ESG ratings on all the Index constituents. The Fund does not commit to making sustainable investments within the meaning of the SFDR or the Taxonomy Regulation. The Fund may hold 10% of its assets in cash or cash equivalents and derivatives used for currency hedging and efficient portfolio management purposes, at the Investment Manager's discretion. Such assets will not be aligned with environmental and social characteristics, nor will there be any environmental or social safeguards in place.

The Fund does not commit to making sustainable investments within the meaning of the SFDR or the EU Taxonomy Regulation.

The portfolio of the Fund is predominantly composed of securities that comply with the ESG standards outlined above and in the index methodology (and in ensuring that the portfolio is exempt of issuers having activities that would significantly harm this objective).



F. Monitoring of environmental or social characteristics

Attainment of the relevant characteristics is evaluated using the indicators described below. The Index aims are:

- A reduction of overall greenhouse gas (GHG) intensity compared with the Parent Index;
- A minimum decarbonisation rate of GHG intensity reduction per year
- Exposure to sectors with a high impact on climate change at least equivalent to the Parent Index to align with the objectives of the Paris Agreement to include exposure to sectors that should actively reduce GHG emissions.

The index takes into account:

- Increased exposure to companies that publish emissions reduction targets, publish their annual emissions and reduce their GHG intensity;
- Contribution to reduced weighted average potential emissions intensity compared with the Parent Index;
- Contribution to increased overall low carbon transition (LCT) score compared with the Parent Index (i.e., lower overall exposure to companies facing risks from LCT and / or higher overall exposure to companies which may have opportunities from LCT), as determined by the index provider;
- Reduction in exposure to physical risk arising from extreme weather events compared with the Parent Index
- Contribution to increased overall exposure to companies with a minimum green-to-brown revenue
 ratio compared with the Parent Index with green revenues being those which reflect company
 revenues from products and services that have the potential to contribute to the low carbon
 transition versus brown revenues which have the potential to harm the environment and worsen
 the low carbon transition (for further information on the meaning of green and brown revenue and
 how they are calculated please refer to the index methodology);
- Contribution to increased overall green revenue compared with the Parent Index; and
- Constituent-level liquidity and diversification caps.

The Fund rebalances on a semi-annual basis, in line with the Index rebalancing frequency.



G. Methodologies

The index methodology which captures the environmental or social characteristics promoted by the financial product is made available in the fund supplement.



H. Data sources and processing

The data sources used to attain the relevant environmental or social characteristics are detailed in the index methodology.



I. Limitations to methodologies and data

There is a risk that the index provider may make errors, such as incorrect assessment of the screen criteria described in the Investment Policy and/or include incorrect/exclude correct constituents in the screening process. ESG scoring and screening is subject to inherent methodological limits. Any assessment of ESG criteria by an Index is based on the data provided by third parties. Such assessments are dependent upon information and data that may be incomplete, inaccurate or unavailable, which could cause incorrect assessment of an issuer's ESG performance. In particular there may be potential inconsistencies, inaccuracy or a lack of availability of required ESG data, particularly where this is issued by external data providers. These limitations may include but are not limited to issues relating to: - Missing or incomplete data from companies (for example, relating to their capacity to manage their Sustainability Risks) which have been used as input for any scoring model; - The quantity and quality of ESG data to be processed; and - The identification of relevant factors for the ESG analysis.

ESG data may be based on certain assumptions, forecasts, projections, views and opinions which may be based on current market trends or anticipated future events. To assess company involvement in different activities and to estimate revenue shares as accurately as possible, data

providers strive to obtain information directly from companies and issuers. Sources of data include annual reports, regulatory filings, sustainability reports, press releases, investor presentations, company websites, and other company disclosures. Given the developing and innovative nature of data models, methodologies and assumptions and the inherent uncertainty in predicting forward-looking events, it cannot be guaranteed that the ESG data is always accurate or correct or that the ESG data will satisfy the aims or requirements of any specific client or investor. Furthermore, there may be data that cannot be sourced due to the lack of availability of data sources.



J. Due diligence

SSGA oversees external vendors, including index providers, in line with its third party risk management programme. SSGA engages with index providers regularly for service level reviews and also undertakes targeted reviews of index providers' processes, systems & systems controls, data, quality controls & IT security.

While SSGA engagement policies are not directly embedded into the Fund's investment strategy, for SSGA the informed exercise of voting rights coupled with targeted and value-driven engagement is the most effective mechanism of creating value and managing Sustainability Risk for the investors. SSGA's Asset Stewardship programme consolidates all voting and engagement activities across asset classes, irrespective of investment strategy or geographic region. The engagement strategy is built on SSGA's ability to prioritise and allocate resources to companies and issues that have the greatest potential impact. SSGA's Asset Stewardship programme is underpinned by 3 separate pillars, that is, (i) providing information and guidance to investee companies on the development of ESG practices across key issues, (ii) engaging with portfolio companies to encourage transparent, accountable, high performing boards and companies, and (iii) by exercising voting rights in a manner that reflects long term investment objectives for the purpose of influencing the activity or behaviour of the issuers. To support this process, SSGA has developed proprietary in-house tools to help identify companies for active engagement based on various financial and ESG indicators.
