**SSGA SPDR ETFs Europe II plc (the "Company")**

**Extension of Securities Lending for certain SPDR ETFs**

We are writing to you as a Shareholder in one or more of the Funds listed in Schedule 1 of this notice (each being a "fund" and together the "Funds"), to advise that the Directors have determined that the Funds will soon participate in the securities lending programme, as outlined below (the "Programme").

**Extension of the Programme & Effective Date**

The Directors have determined that:

- each Fund listed in Schedule 1 may commence their participation in the Programme on or about 27 October 2023 or such later date when the Central Bank notes the changes to the relevant Fund Supplements.
- For fixed income Funds participating in the Programme, the Fund's maximum exposure to securities lending as a percentage of its Net Asset Value will not exceed 70%.
- For equity Funds participating in the Programme, the Fund's maximum exposure to securities lending as a percentage of its Net Asset Value remains the same and will not exceed 40%.
- SPDR UCITS ETFs with an SFDR Article 8 classification will not participate in the Programme at this time.

Implementation of the Programme is expected to improve the cost effectiveness of ETF ownership.


