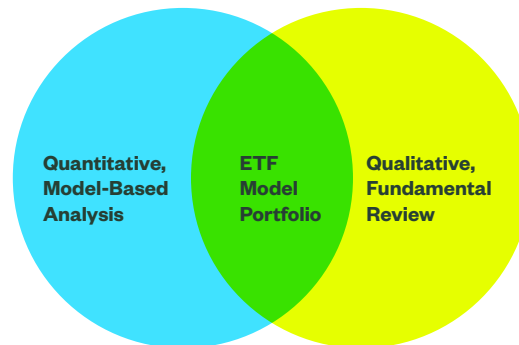
Efficient
